Quality Fish seed is one of the key for augmenting fish production. Genetically improved brood stock forms the critical component in aquaculture which is directly related to the seed quality and productivity. With use of good quality seed, aquaculture production can be enhanced as much as 15-20% without additional input or cost. The adoption of genetically improved strains will have faster growth rate leading to increase fish production, enhance profitability, and economic gain for the fish farmers as well as the nation.

National Freshwater Fish Brood Bank (NFFBB), Bhubaneswar under the aegis of National Fisheries Development Board was established in the year 2013 with the main objectives of NFFBB is to maintain good quality and/ or genetically improved Fish brood-stock duly obtained from research organizations with proper package and management protocols and multiplication of these Genetically Improved Fish Species (GIFS) brood-stock in order to produce breeder seed and distribute these breeder seed (fry/fingerlings) to accredited hatcheries as source for brood stock for further multiplication and supply to farmers to meet the seed demand from across the states in support of fisheries sector growth.

With this background, NFDB-NFFBB is inviting applications from the potential hatcheries and seed growers situated at different states in the country for enrolment as an registered network hatcheries and registered seed growers. The applicant has to apply in the prescribed format enclosed along with this notice along with the required documents and registration fee. The filled in application should reach to the

## **Terms and conditions :-**

1. Incomplete Applications in any respect will be summarily rejected.
2. NFDB, Hyderabad reserves all rights to accept or cancel the process of registration at any point of time.
3. In case of any ambiguity or complain with regard to selection and registration process may be addressed to The Chief Executive, NFDB, Hyderabad, Telangana.
4. The decision of the Chief Executive, NFDB, Hyderabad in the process of selection of registration of hatchery shall be final.
5. Disputes if any arising out of this program will have to be settled within the jurisdiction of Hyderabad court only.
6. The Registered Hatchery/Seed Growing Unit will have to allow NFDB official at any point of Time for Monitoring, recording of data.
7. The Firm should always follow the SOP and maintain integrity in maintaining the purity of the stock.
8. The registration is liable to cancelled at any point of time if found non compliance of the terms and conditions and providing false information.

## **Eligibility**

### **Basic Requirements of the Hatchery**

The following are the three basic requirements for initiating the process of fish seed certification and accreditation process of hatcheries.

- Over Head Tank (capacity  $\geq 40 \text{ m}^3$ )
- Minimum one spawning pool (dia 4 to 5 M)
- Four hatching pools (dia 2.5 M)
- Collection chamber
- Should at least produce about 60 Million Spawn in an year
- 1 ha of nursery and Breeder seed rearing ponds.
- 0.5 Ha brood stock ponds
- Permanent water source with desired quality

### **Basic Requirements of the Seed growers (Nursery/ Rearing) – Fingerling Producers**

The seed growing network units are required to maintain the following criteria.

- Minimum of 1 ha rearing area (WSA-1ha)
- Should have bio-security facilities (Bird fencing and Crab fencing)
- Should have permanent water source of desired quality
- Should have tie up Grow-out farmers for seed lifting

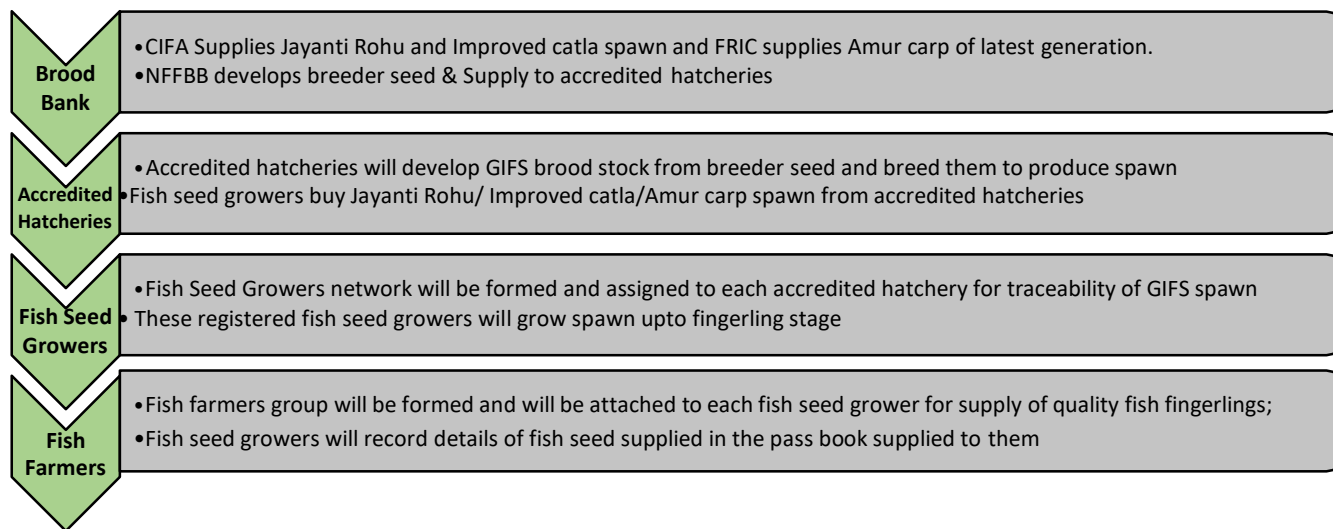
