

Empanelment of Consultants / Consulting Firms for technical and managerial support services in Fisheries & Aquaculture

1: Introduction:

India is bestowed with wide array of natural resources for developing marine, brackish water and inland fisheries and aquaculture. It is one of the largest fish producing countries in the world contributing 1.24% to India's Gross Value Added (GVA) and 7.28% (2018-19) to the agricultural GVA, fisheries and aquaculture continue to be an important source of food, nutrition, income and livelihood to millions of people in India. This sector provides livelihood to about 25 million fishers and fish farmers at the primary level and twice the number along the value chain.

Over the last few years, the fisheries sector of India has made impressive strides towards modernization and sustainable economic growth through concerted and collaborative efforts by the government and private sectors.

2: Current Empanelment Status

NFDB, Department of Fisheries, Ministry of Fisheries, Animal Husbandry & Dairying, Government of India has carried out an exercise for "Empanelment of Consultants /Consulting Firms for technical and managerial support services in Fisheries & Aquaculture sector" to create a pool of expert consultants/firms for providing technical support and hand holding services in the fisheries sector to be implemented by the State Fisheries Departments across the country &Fishers & Fish farmers and Entrepreneurs and other stakeholders etc.

NFDB issued first notification on 30.03.2021 and 49 individual consultants/consulting firms have been empanelled and their validity is upto 05-07-2023. Through the Current notification NFDB intends to issue second notification for Empanelment of Consultants /Consulting Firms for technical and managerial support services in Fisheries & Aquaculture sector for the year 2022-23 up to a period of 2023-24. The empanelment process is open-ended. The validity of this 2nd empanelment will be till 31.07.2024. Already empanelled entities shall not apply for the second notification. The list of category wise newly empanelled Consultants /Consulting Firms for technical and managerial support services in Fisheries & Aquaculture sector shall be uploaded once list is finalised by NFDB on Website.

3: Concept of empanelment of consultants & consulting firms:

Fishers, Fish Farmers, Fish Workers, Fish Vendors, Entrepreneurs, Private Enterprise Firms, Government & Private Organizations, Academic, Research & Training Institutions, Manufacturers, traders, consumers, etc play a vital role contributing to fisheries development across the value chain. It is observed that there has been a quest from all sections for support in accessing information and technical guidance in taking up fisheries- based activities. Realizing this, the National Fisheries Development Board intends to create a common platform by empanelling Consultants & Consulting Firms for information and knowledge dissemination and provide technical and managerial support services to various stakeholders under the scheme.

4: Purpose of empanelling consulting services in Fisheries:

While implementing various schemes for development of fisheries, it is observed that there is a need for information and technical guidance across different players as mentioned below:

In order to bridge the gaps in accessing information/knowledge/skill requirements among various players in fisheries sector, pooling of experts and expert firms for rendering consultancy services through empanelling is felt essential and important.

5: Objectives of empanelling consultants/ Consulting Firms

The following objectives are laid down for the purpose:

- To contribute to fisheries sector growth through disseminating information/knowledge/ skills to the primary and secondary stakeholders by expert resource pool empanelled as consultants/ consulting firms.
- To create a common platform as one stop solution for various players across value chain of fisheries for all expert consultations and guidance.
- To create employment for young and qualified professionals in fisheries.
- To complement best human resource utilization in fisheries sector for collective development in turn contributing to fisheries development and enhancement of livelihoods of the target beneficiaries.

6: Who can be empanelled?

- Qualified professionals from Private Sector / Freelancers with specialization in fisheries sector having experience in relevant field.
- Retired Government employees of fisheries department & related institutions
- Consulting Firms/ Entrepreneurs/ Enterprise Firms registered under any Indian Registration Laws as Proprietorship firm/ Partnership firm registered under LLP Act, 2008/Indian Partnership Act, 1932 or Company in India as per Indian Companies Act, 1956 or Indian Companies Act, 2013, Indian Trusts Act, 1882, Societies Registration Act, 1860 having expertise in implementing Fisheries projects.
- Academic / Research / Training Institutions relevant to the fisheries (or) having experience in implementing fisheries projects

7: Who can avail services?

All individuals/Entities in need of consultancy services for taking up directly/for promotion of fisheries & aquaculture related activities can approach and avail the services of the empanelled consultants/firms by NFDB. Users / Clients can be:

- Fishers, Fish Farmers, Fish Workers and Fish Vendors.
- Self Help Groups (SHGs)/ Fisheries Cooperatives/Joint Liability Groups (JLGs)
- Fish Farmer Producer Organizations/Companies(FFPOs/Cs).
- Individual Entrepreneurs and private entities/ firms.
- Government Departments/Institutions.
- Private Organizations registered as Proprietorship firm / Partnership firm/LLP/Company in India.
- Development Fund) and any other relevant Fisheries/Aquaculture related schemes.

8: Who will empanel?

National Fisheries Development Board (NFDB), Hyderabad, an autonomous organization under the administrative control of the Department of Fisheries, Ministry of Fisheries, Animal Husbandry & Dairying, Government of India shall empanel consultants / consulting firms for providing managerial & technical support services in fisheries sector.

NFDB will empanel consultants /consulting firms with expertise in fisheries sector through selection criteria and will place their details in its website: nfdb.gov.in. Empanelled Consultants/ Consulting Firms shall provide managerial / technical support services on service fee basis. All those users/clients requiring guidance support have to visit the NFDB website and can avail consultancy services.

10: Procedure for empanelment:

Interested consultant/consulting firm shall submit application in the prescribed form within the stipulated date. All applications received from individuals/firms shall be scrutinized and empanelled after approval of the Committee constituted for the purpose.

- NFDB will constitute a committee to screen and examine the competency of the individual /firm.
- All applications received for the purpose, within the given timeline, will initially be screened by the committees for completeness of the application and then scrutinize the profiles as per the eligibility criteria through the set selection process.
- Consultants / consulting firms that are shortlisted shall then be categorized into groups as per the subject category defined at Sl.No.10.
- The list of the empanelled consultants/ consulting firms will be uploaded in the NFDB website duly informing the firm through written communication.

11: Categorization of consultants / Consulting Firms

The services of Consultants / Consulting Firms are required for support at various stages of planning, implementation, monitoring of project components viz., community mobilization, organizing target fishers/ fish farmers into SHGs/JLGs/Fishers Cooperatives/Fish Farmer Producer Organizations, capacity building in various thematic areas, site selection, preparation of Detailed Project Reports/Self Contained Proposals, handholding support / technical guidance in project implementation, development of online monitoring systems, entrepreneur development, etc.

Based on the specializations and services required, the following categorization is proposed for engagement of the professionals:

12: Engaging empanelled Consultants / Consulting Firms by users/clients:

As per the requirement of the Institution/ Project, the users may directly consult the empanelled consultants / consulting firms by browsing through the list placed in the NFDB website, seek quotations, negotiate & process further for engaging the individuals / firms based on the type of work & size of the project (in terms of cost). The users will have to pay the consultancy fee to the consultants/firms engaged based on the nature, uniqueness, complexity, size and location of the project.

A. Engaging consulting services for "Institution & capacity building" category:

B. Engaging consultancy services for "DPRs/SCPs preparation":

This will be a short time engagement for preparing the DPRs/SCPs for required projects by the User. Empanelled Individual Consultants/Consulting Firms can be approached directly by the Users and engage their services at mutually agreed terms. Consultancy charges shall be considered for not exceeding 3% (inclusive of GST) of the total value of the project/ assignment by User/Client and also subject to the mutually agreed terms and conditions.

C. Handholding / Technical support in implementation of projects components:

Under this category, the engagement of consulting services is usually on long term basis provided by the consultants /Consulting Firms. The user shall engage empanelled consulting firms directly by inviting quotations/RFPs/Tenders, etc at mutually agreed terms.


D. Multipurpose engagement:

User Department/Client may require consulting services for all the above said A,B & C purposes such as project designing, action plan/DPR preparations, institution & capacity building, project implementation, monitoring, evaluation & documentation etc. The user shall engage empanelled consulting firms directly by inviting quotations/RFPs/Tenders, etc. at mutually agreed terms.

13: General Terms & conditions:

- 1. Empanelment of Consultants/ Consulting Firms by NFDB is not an offer for direct service to NFDB but to be listed for being engaged to render services to the stakeholder such as Fishers/Fish Farmers/ Societies/Federations/Enterprise firms/etc involved in Fisheries & Aquaculture sector.
- 2. NFDB reserves all rights to empanel the individual / firms for providing consultancy services based on the profile, experience and contribution to the fisheries sector.
- 3. NFDB shall not assure of providing services directly either by NFDB or from clients/users.
- 4. The empanelment is a continuous process and is open-ended. The Validity of empanelment for individual/firms which will be empanelled as per this notification will be up to 31/07/2024. The empanelled list on the NFDB portal shall be updated every month based on the applications received in that month.
- 5. NFDB website is having information of empanelled Consultants/Consulting Firms. The complete accuracy and integrity of data submitted in respect of the consultant/firm and also in respect of services offered and compliance with the applicable laws is sole responsibility of the Consultant/Firm.
- 6. Empanelled Consultants/Consulting Firms would be solely and absolutely responsible for the information provided about their organization, business, products, materials and prices on their portal.
- 7. NFDB shall reserve the right to delist/cancel empanelled consultant/ consulting firm at any point of time if found fraudulent / involved in legal issues/ misappropriations/ poor service delivery, etc.
- 8. It is not mandatory that the user shall avail only the listed consultants/consulting firms.
- 9. NFDB is not responsible for any financial transactions/delay in financial settlements between Consultant/ Firm & User clients or any disputes arising thereof.
- 10. Listed member can withdraw at any point of time from the empanelled list by submitting requisition to NFDB and with reasons for withdrawal.
- 11. NFDB, Hyderabad, reserves the right to accept, reject or cancel the applications at any time without assigning any reasons thereof and decision will be final and binding and no further correspondence will be entertained.
- 12. Any dispute or claim arising out of or relating to this Notice, its validity, breach or termination with regard to the empanelling of the consultant/ consulting firm on NFDB portal thereof, shall be settled by Arbitration in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996, by referring to an Arbitrator, appointed by NFDB, on mutual consent. The place of Arbitration shall be at Hyderabad. The award of arbitration shall be final and conclusive and binding upon both the parties. The parties are entitled to contest the arbitration award only in the Hon'ble High Court of Judicature, Hyderabad.
- 13. All disputes in connection with the contract between empanelled consultant/ consulting firm and user/client shall be subject to the exclusive jurisdiction of the court within the local limits

- of the jurisdiction where the contract was executed. NFDB would not be a party to any such dispute matter.
- 14. Individual consultants/consultancy firms can only quote that they are in the empanelled list of Consultants /Consulting Firms by NFDB but should not quote or do publicity that they are promoted by NFDB or themselves as consultants working with NFDB directly.
- 15. Disclaimer: NFDB, Hyderabad is not promoting any Consultant/Consulting Firm. NFDB is not responsible for any conflicts between the service provider and the client or for any fraud or failure of the service delivery related issues.

- 1.3 Application shall be submitted by a single entity only. A joint venture/consortium of entities shall not be eligible for submission of Application and/or for consideration for the Project in any manner whatsoever.


