I am directed to refer to the captioned subject and to inform that the approval of Government of India for implementation of "Pradhan Mantri MatsyaSampada Yojana (PMMSY) - A scheme to bring about Blue Revolution through sustainable and responsible development of fisheries sector in India" at a total investment of Rs. 20050 crore (Rupees: Twenty thousand fifty crore only) for a period of 5 (five) years from FY 2020-21 to FY 2024-25 in all the States and Union Territories (UTs) has been conveyed vide letter No. J- 117012-1/2020 dated 12th June, 2020.

2. In continuation, approval of the Competent Authority is hereby conveyed for implementation of the "Pradhan Mantri MatsyaSampada Yojana (PMMSY) - A scheme to bring about Blue Revolution through sustainable and responsible development of fisheries sector in India" with a total central outlay of Rs 1000 crore (Rupees: One thousand crore only) during the financial year 2021-22in all the States and Union Territories (UTs). The head-wise details of allocated central outlay for implementation of the PMMSY during the year 2021-22 is as below:

3. The PMMSY is implemented as an umbrella scheme with two separate Components namely (a) Central Sector Scheme (CS) and (b) Centrally Sponsored Scheme (CSS). The Centrally Sponsored Scheme (CSS) Component is further segregated into Non-beneficiary oriented and beneficiary orientated sub-components/activities under the following three broad heads:

- (i) Enhancement of Production and Productivity
- (ii) Infrastructure and Post-harvest Management
- (iii) Fisheries Management and Regulatory Framework

4. The PMMSY intends to address critical gaps in fish production and productivity, quality, technology, post-harvest infrastructure and management, modernisation and strengthening of value chain, traceability, establishing a robust fisheries management framework and fishers' welfare.

5. The detailed Operational Guidelines indicating the funding pattern, mode of submission of proposals, evaluation and approval of proposals, fund release and monitoring mechanism, cost norms withassociated terms and conditions for implementation of various activities under the components and sub-components of the PMMSY have been issued vide this Departments' letter No. J-117012-3/2020 dated 24th June, 2020. Besides, wherever essential, specific guidelines in respect of various activities/sub-components of the PMMSY have also been issued from time-to-time.

6. The Operational Guidelines of PMMSY and specific guidelines wherever necessary in respect of various activities/sub-components of PMMSY issued from time-to-time are uploaded in the Department's website (*http://www.dof.gov.in*).

7. State Governments/UT Administrations and other concerned agencies are requested to formulate specific action plan, strategy and roadmap for development and management of fisheries in their respective States/UTs. The State Governments/UTs are also requested to sensitize all the concerned fisheries stakeholders such as Fishers, Fish farmers, Fish workers and Fish vendors, Fisheries Development corporations, Self Help Groups (SHGs)/Joint Liability Groups (JLGs) in fisheries sector, Fisheries cooperatives, Fisheries Federations, Entrepreneurs and private firms, Fish Farmers Producer Organizations/Companies (FFPOs/Cs)/SCs/STs/Women/Differently abled persons etc. about the PMMSY in order to get the proposals from the eligible beneficiaries/entities.

8. Besides, the State Governments/UT Administrations, Central Fisheries Institutes/ Organizations and others are requested to submit self contained project proposals in respect of the desired activities in accordance with the provisions and operational guidelines of the PMMSY for availing central financial assistance under the scheme. Availability of adequate matching budgetary provision in State budget, necessary clearances and land wherever necessary, need to be specifically indicated in the proposals.

- 9. This administrative approval is issued subject to the following:
 - (i) The provision of General Financial Rule, 2017 shall be applicable.
 - (ii) Release of funds shall be as per Cash Management System Guidelines, if any, issued by the Budget Division, Department of Economic Affairs, Ministry of Finance.
 - (iii) The flow of funds is to be ensured through PFMS/DBT platforms.
 - (iv) The Central/State Implementing Agencies shall ensure registration of all implementing agencies till last level and use of Expenditure, Advance and Transfer (EAT) module of Public Finance Management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per the Rule (232) (v) of GFR 2017.
 - (v) Utilization Certificates shall be through PFMS in accordance with Guidelines issued in this regard by CCA, Ministry of Fisheries, Animal Husbandry and Dairying. It is to be noted that Utilization Certificate not supported by EAT module is likely to be rejected and expenditure will not be treated as regular.
 - (vi) Instructions of Ministry of Finance issued vide their OM F.No.1(13)PFMS/FCD/2020 dated 23.03.2021on the subject" Procedure for release of funds under the CSS and monitoring utilization of the funds released on PFMS" shall be strictly followed.
- 10. This issues with the approval of the Competent Authority.
