# **Section I**

## **Details of Empanelment of Equipment Manufacturers / Suppliers in the Fisheries & Aquaculture Sector**

# **Empanelment of Equipment Manufacturers / Suppliers**

## **1. Background:**

The fisheries and aquaculture sector is growing rapidly in India with millions of people dependent for their livelihoods on fisheries directly and indirectly. The recent growth in the sector is determined by the increasing production & productivity as a result of increased focus of the Government and private sector by initiating large scale projects with huge investments, growing demand for fish consumption, increase in incomes, innovations & introduction of the latest technologies viz., Cage culture, Pen culture, Aquaponics, Re-Circulatory Aquaculture, Bio floc system, Aqua Hubs, etc., increase in export sales, etc. This industry includes various activities concerned with fishing, culture, production, manufacturing, preservation, processing, storage, transportation, and marketing of fish and fish products. Fishers, Fish Farmers, Entrepreneurs, Fish vendors, Fish Workers, organized institutions such as Joint Liability Groups, Self Help Groups, Cooperative societies, Fish Farmer Producer Organizations, Manufacturers, Hatchery owners, traders, consumers, and Government & private organizations are some of the key role players involved across the fisheries value chain and are contributing to the development of the sector.

## **2. Current Empanelment Status:**

NFDB, Department of Fisheries, Ministry of Fisheries, Animal Husbandry & Dairying, Government of India has carried out an exercise for empanelment of Manufacturers / Suppliers in Fisheries and Aquaculture sector to create a pool of Manufacturers and Suppliers for providing quality & timely delivery of equipment and machinery to implement various schemes/projects in the fisheries sector by the Department of Fisheries of the States / UTs, Fishers & Fish farmers and Entrepreneurs and other stakeholders.

The notification for empanelment for the first time was issued on 17.03.2021 and 47 firms have already been empanelled and their empanelment is valid till 25<sup>th</sup> May 2023. Currently, NFDB intends to issue the second notification for empanelment of equipment manufacturers/suppliers in the fisheries sector for the year 2022-23 and 2023-24.

The empanelment of equipment manufactures/suppliers process is open-ended. The validity of this 2<sup>nd</sup> empanelment will be till 31.07.2024. Already empanelled entities shall not apply for the second notification. The list of newly empanelled equipment manufacturers/suppliers with the items/equipment list & specification will be uploaded on NFDB Portal.

## **3. Purpose of empanelment of Equipment Manufacturers:**

Fishers, Fish farmers and Entrepreneurs are in constant search of the availability and supply of quality equipment and machinery at affordable prices for various culture &

capture-based fisheries activities in their reach. Equipment like gear(net), electrical pumps, aerators, air blowers, compressors, generators, oxygen generators, feed dispensers, cage material, tanks for Bio floc /RAS / Aquarium, hatcheries, feed/ mill, cold storage, refrigerators, processing & packing & Ice making machines, storage material, lab equipment, safety kits, water testing kits, plastic crates, weighing balances, etc. are mostly procured items by them. In order to optimize the production and productivity of the pond ecosystem, the availability of different types of machinery/implements for the farming system is very much needed. But, access to information related to various products/machinery and their equipment manufacturers and suppliers is very minimal.

The need for aggregation of all potential manufacturers & suppliers of fishing and aquaculture equipment & machinery at a common point through empanelment is felt with various schemes/projects being implemented in all states/UTs of the country. This will provide beneficiaries with end to end support for the holistic development of the fisheries sector. To enable beneficiaries to select suitable manufacturers and suppliers of their choice and requirement as well as ensure quality and timely delivery of equipment & machinery at affordable prices, National Fisheries Development Board (NFDB) intends to empanel equipment manufacturers & suppliers and place their list in the NFDB website for the benefit of stakeholders.

#### **4. Objectives:**

- To identify and empanel eligible manufacturers and suppliers of equipment & machinery related to fisheries & aquaculture.
- To facilitate quality & timely delivery of equipment and machinery to the end-users by empanelling manufacturers & suppliers.
- To enhance production, productivity and profitability across the value chain through the creation of a common platform for suppliers/ users.
- To foster linkages among producers, aggregators, processors, suppliers and exporters for better Price realization and enhanced incomes.
- To develop and improve the procurement and operational systems of equipment & machinery in the fisheries sector.

#### **5. Who can apply?**

Any registered Firm/ Company engaged in manufacturing/supply of equipment, accessories, input suppliers & machinery related to fisheries & aquaculture and are registered mentioned below:

- Proprietorship firm
- Partnership firm registered under LLP Act, 2008 / Indian Partnership Act, 1932 (or) Company in India as per Indian Companies Act, 1956 (or) Indian Companies Act, 2013
- Micro, Small and Medium Enterprises (MSME)

- Societies registered under the Cooperative Society Act.

## 6. Who can avail of services?

All individuals/entities in need of equipment/ machinery for taking up directly or for promotion of fisheries & aquaculture related activities can approach and avail of the services of the empanelled manufacturers. Users / Clients can be:

- Fishers, Fish Farmers, Fish Workers and Fish Vendors
- Self Help Groups (SHGs)/ Fisheries Cooperatives/Joint Liability Groups (JLGs)
- Fish Farmer Producer Organizations/Companies (FFPOs/Cs)
- Individual Entrepreneurs and private entities/ firms
- Government Departments/Institutions
- Private organizations registered as Proprietorship firm / Partnership firm/ LLP/Company in India
- International Organizations having a presence in India with all legal permissions
- Beneficiaries of Fisheries and Aquaculture related schemes.

## 7. Who will empanel?

National Fisheries Development Board (NFDB), Hyderabad, an autonomous organization under the administrative control of the Department of Fisheries, Ministry of Fisheries, Animal Husbandry & Dairying, Government of India intends to empanel Manufacturers/Suppliers for providing Equipment/Machinery in the fisheries sector.

NFDB will empanel Equipment Manufacturers/Supplier firms with expertise in the fisheries sector through robust selection criteria and will place their details in its website: [nfdb.gov.in](http://nfdb.gov.in). Empanelled manufacturers/suppliers shall deliver services to the users/ clients as per the mode of selection (direct selection/ EoI / RFQ / Tenders, others) defined by the users/clients. All those individuals/ institutions/ Organizations requiring equipment/machinery related to fisheries & aquaculture may have to directly approach the concerned firms for services.

## 8. Eligibility Criteria:

- The firm should be registered under any Indian Registration Laws as a Proprietorship firm/ Partnership firm registered under LLP Act, 2008 / Indian Partnership Act, 1932 or Company in India as per Indian Companies Act, 1956 or Indian Companies Act, 2013 or Cooperative Society Act.
- Should have a registered office in India and should be in existence and should be engaged in manufacturing or supply of equipment/ machinery related to fisheries & aquaculture for a minimum period of 1 year.
- Firms should have a minimum of Rs.5 lakhs as an average annual turnover in last 1 or 2 FYs for firms with experience of 1 to less than 3 years and for the last 3 FYs for the firms with 3 years and above experience.
- For the firms with 3 years and above experience, shall produce audit reports & IT

filing details for the last 2 financial years and firms with one-year experience, should either submit an audit report (or) if not yet audited, shall submit self-declaration duly mentioning the reasons and self-attested.

- Should have GST registration and PAN number.
- Should have all required licences/permissions of establishment and test certificates conforming to relevant specifications from Government recognized/ authorized institution/s as applicable.
- Should have a current client base from fishers/fish farmers/owners of Hatchery, RAS, feed mills, processing units, aquaculture ponds, Central – State Govt. Departments, Public/Pvt Ltd Companies etc.
- Firm should have manufactured and or supplied in any one year during last three years, particularly the item /product for which they want the empanelment.
- Should not have been blacklisted/barred/disqualified by any Govt. or regulator/statutory body or institution during the last two years.
- Service operational area within District/State/National/International.
- Should be in a position to supply indented equipment/machinery in time with after-sales service.

## 10. Procedure for empanelment of Equipment Manufacturers/Suppliers:

All applications received from firms shall be scrutinized, graded and empanelled after approval of the Committee constituted for the purpose.

### Constitution of Empanelment Committee by NFDB:

- NFDB will constitute committees to screen and examine the competency of the firms as per the eligibility criteria.
- All applications received for the purpose, within the given timeline, will initially be screened by these committees for completeness of the application and then scrutinize the profiles as per the eligibility criteria through the set selection process.
- Shortlisted firms shall then be categorized into two, based on the years of experience, i.e., 3 years and above & Minimum 1 to less than 3 years as mentioned below:

- Shortlisted applications with recommendations and those not complying with the requirements with the reasons shall be put up to the competent authority for approval on empanelment or rejection.
- Upon approval, the list of the Manufacturers/ Suppliers of Equipment & Machinery will be uploaded in the NFDB website duly informing the firm through written communication.

### 11. Engagement of Manufacturers/Suppliers of Equipment/Machinery by Users / Clients:

**Direct engagement:** As per the requirement for the supply of equipment/machinery, the users may directly consult the empanelled Manufacturers/Suppliers from the website of NFDB. NFDB will not take any responsibility for the goods/work delivered by the firm, financial agreements, disputes etc., between the Empanelled firm & User/Client. However, the user/empanelled firm may share the feedback with the NFDB on the service delivery and client response.

### 12. List of Documents to be furnished by the Applicant:

The applicant should submit the following documents for eligibility:

1. Filled in application form (Annexure I)
2. Proof of Identity of the applicant (Copy of Passport/ Aadhaar Card/Driving Licence) duly attested by authorized signatory
3. Authorization letter of the Firm declaring the authorized signatory for submission of application and all relevant documents
4. Proof of Registered office address
5. Copy of registration of Firm (Proprietorship/ partnership/ Pvt. Ltd comp/Public Ltd. Company/ Registered Society/Govt. Agency)
6. Copy of GST Registration (valid registration of the Company etc.)
7. Copy of PAN Card
8. Income Tax Returns (ITR) for min 2 years for firms with 3 years and above experience. Minimum 1 or 2 years ITR for the firm with minimum 1 year to less than 3 years of existence and in case of not yet filed shall submit self-declaration with reasons and self-attestation.
9. Copy of bank account details on name of Individual Entrepreneur/ Private Firm duly attested
10. Details of Financial Turnover of last 3 years certified by a Chartered Accountant for the firms with above 3 years' experience. For firms having 1 to 3 years' experience, year wise financial turnover certified by a Chartered Accountant or

Self-certified bank statement shall be submitted.

11. Test certificates conforming to relevant specifications from Government recognized/ authorised institutions.
12. Detailed list of manufacturing and analytical equipment with copies of bills/ invoices or supply orders or any documentary evidence to validate that the applicant has been manufacturing/supplying the goods under the category they are applying for.
13. Website details, if any.

### **13. General Terms & conditions:**

1. Empanelment of Manufacturers/Supplier Firms by NFDB is not an offer for direct service/work to NFDB but to be listed for being engaged by various stakeholders such as Fishers/Fish Farmers/ Societies/Federations/Enterprise firms/etc. for manufacturing/supply of Equipment/Machinery related to the Fisheries & Aquaculture sector.
2. NFDB reserves all rights to empanel the manufacturers/ Supplier firms for the supply of Equipment/Machinery based on the credentials, experience and other eligibility parameters defined for the selection process.
3. NFDB shall not assure of providing contracts/works to the empanelled firms either directly by NFDB or from clients/Users.
4. The empanelment is a continuous process and is open-ended. The Validity of empanelment for firms which will be empanelled as per this notification. will be up to 31/07/2024. The empanelled list on the NFDB portal shall be updated every month based on the applications received in that month.
5. NFDB website is having information of empanelled manufacturers/suppliers. The complete accuracy and integrity of data submitted in respect of the seller and also in respect of goods offered and compliance with the applicable laws is sole responsibility of the seller.
6. Empanelled manufacturers/suppliers would be solely and absolutely responsible for the information provided about their organization, business, products, materials and prices on the portal.
7. NFDB shall reserve rights to delist/cancel the empanelled firms at any point of time, if found fraudulent/involved in legal issues/ misappropriations/ poor service delivery, etc.
8. It is not mandatory that the user shall avail only the listed manufacturers/suppliers.
9. NFDB is not responsible for any financial transactions/delay in financial settlements between manufacturers/suppliers & users/ clients.
10. NFDB shall not guarantee for the quality of the equipment/ machinery supplied by the empanelled firms to the users/clients.
11. Listed members can withdraw at any point from the empanelled list by submitting a requisition to NFDB along with reasons for withdrawal.

12. NFDB, reserves the right to accept, reject or cancel the applications at any time without assigning any reasons thereof and the decision of NFDB will be final and binding and no further correspondence will be entertained
13.
